

# USAID Youth Actively Create Opportunities Activity

## Request for Applications (RFA)

### 1. BACKGROUND

The United States Agency for International Development (USAID) Youth Actively Create Opportunities Activity is a five-year initiative aiming to increase positive youth contributions to society and collective youth leadership. To achieve this, IESC and Macedonian partners Center for Entrepreneurship and Executive Development (CEED) Hub Skopje and Youth Educational Forum (YEF) prioritize a youth-centered local systems approach to jointly implement activities under the Activity’s three Components:

- Component 1: Partnerships created to support economic opportunities attractive to youth.
- Component 2: Youth’s competencies for jobs, progressive careers, and civic life strengthened.
- Component 3: Values and experience that underpin self-reliance promoted.

### 2. OBJECTIVE & SCOPE

Youth Actively Create Opportunities Activity is seeking full applications for grants activities that accelerate and expand upon Activity’s objectives to address youth priorities and increase youth economic opportunities, competencies and youth civic engagement in North Macedonia. The following grant packages are available:

RFA YACO 01 – 2023	Rapid Response Grant	Addresses specific youth challenges and immediate youth priorities through implementation of activities. The proposed activities should be designed to identify and fund youth-led solutions across the country, increase positive youth contributions to society and collective youth leadership	\$10,000	10%	3 - 9 months
RFA YACO 02 – 2023	Challenge Grant	Addresses systemic challenges youth face to economic opportunities or civic engagement, and include wide implementation, reach and impact. The proposed activities should contribute to high-value training and employment opportunities and ensure equitable inclusion and skills development.	\$40,000	20%	6 - 18 months
RFA YACO 03 – 2023	Sustainable Growth Grant	Addresses long-term strategies, institutional capacity building, organizational development and growth, and in-depth impact. The activities in addition to contributing to high-value training and employment opportunities, youth civic engagement, and ensuring equitable inclusion and skills development, should enhance organizational capacity and ensure sustainable growth.	\$150,000	25%	12 - 24 months

### 3. ELIGIBILITY

Eligible applicants registered in North Macedonia may include youth groups, youth serving organizations, the private sector, community organizations, private education and training institutions, professional or business associations, and NGOs and partnerships of abovementioned organizations. Such partnerships will consist of one lead applicant who meets all eligibility criteria.

Applicants can apply for one, two or all three available grant packages. Furthermore, this request for applications (RFA) is for grant activities under all three Activity Components.

### 4. APPLICATION INSTRUCTIONS

Full applications are due no later than **October 9, 2023 14:00** (UTC/GMT +2 hours) and should be submitted in electronic copy. All applications should reference RFA number and the grant technical description, namely **Rapid Response Grant, Challenge Grant** and/or **Sustainable Growth Grant**. For applicants applying for more than one grant package, separate emails and application documents should be submitted.
